It is necessary for each CSA pool to obtain a signed Swimmer Registration/Release Form for **every swimmer** on your swim team.

A separate form must be completed for each swimmer and signed by their parent or guardian before the swimmer is allowed to participate in any CSA function (this includes swim team practice). Please try to have the forms completed and signed at your organizational meetings, prior to your first practice, so you do not have to pursue parents later in the swim season to obtain signatures. Ensure that each form is:

- Legible
- Complete
- Has swimmer's birthday (including year)
- Signed by parent/guardian

The Registration/Release forms will need to be turned in to me with your team's City Meet Entries. Forms should be alphabetized prior to turning them in. If you have any questions, please contact me at 294-1037 (home) or 698-8804 (work).
